- 1. Welcome and Introductions – Kim Taylor, Chair**
 - a. Board Member Roll Call – Nancy Locke SCRBH (ASO)

- b. The August 2022 minutes were approved as written.
- c. Board Member Update
 - Member Resignation – Ronald Bacon
 - Two (2) new members to introduce at November meeting.
- 2. **Presentation – Ombuds 2022 Third Quarter Report – Gail Kogle, Ombuds:** A brief overview of the reports was provided. The three (3) most common Grievance types for the third quarter included Access, Dignity and Respect, and Phone Calls Not Returned.
- 3. **Presentation - 2022 Q2 Crisis Data Dashboard - Justin Johnson, SCRBH:** A brief overview of the data was provided. Questions were brought up by the board regarding expectations of the crisis response services, the impact of 988 on RCL numbers, and how services are provided to families. Justin provided information on how Individuals access the crisis system, the challenges facing those who are not ITA'd but still refuse services, and what resources are available to families.
- 4. **Administrative Updates – CSHCD SCRBH – Justin Johnson, SCRBH**
 - a. **HOST and SB-SBIRT Update:** A brief overview of the HOST and SB-SBIRT programs was provided. The SB-SBIRT program is continuing to thrive and it will expand to two (2) additional schools. HOST will be up and running on November 1, 2022.
 - b. **Mobile Response and Stabilization Services (MRSS) Update:** A brief update of the MRSS program was provided. A five (5)-year grant was rewarded to further fund this program; the grant allows a team to be sent out to address pre-Crisis Youth emergencies. After the Crisis, the team will provide resources for an additional eight (8) weeks.
- 5. **Consumer Consultation Panel (CCP) Report – Tom Gose** read the minutes from the July and August 2022 meetings.
- 6. **Board Comments –**
 - a) The Evergreen Club will hold a Fun Run on Saturday, October 2, 2022.
 - b) More oversight and screening are needed in group homes and long-term homes.
- 7. **Public Comments – None.**
