The purpose of the public hearing will be for the Board to consider and adopt changes to Spokane County Code Section 46.61.4155.2 and establishing a speed limit of twenty-five miles per hour on Meadowview Road, 21<sup>st</sup> Court, 22<sup>nd</sup> Court, Meadow Court, Clara Road, McMillan Road, Kayla Road, Kayla Court, Whistler Court, Hodges Street, Cavalier Street, Colonial Drive, Meyers Road, Meyers Court, 15<sup>th</sup> Avenue, 13<sup>th</sup> Avenue, 11<sup>th</sup> Avenue, Ellie Mae Avenue, Sheridan Road, Ranchette Road, Ranchette Court, Yearling Road, Avonlea Road, Custer Street and 65<sup>th</sup> Avenue.
