WHEREAS, pursuant to the provisions of RCW 29A.16.040, the Spokane County Auditor, Superintendent of Elections, has recommended that approval to alter 3 precincts due to the City of Deer Park Ordinance 2023-1017 and City of Deer Park Ordinance 2023-1018; and

WHEREAS, pursuant to the provisions of RCW 29A.16.040 (1) no precinct changes may be made during the period starting seven days prior to the first day for candidates to file for the primary election and ending with the day of the general election; and

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Spokane County, pursuant to the provisions of RCW 29A.16.040, that the Board does hereby approve, effective April 24, 2024, the dividing, altering and combining of the voting precincts identified in Attachment "1" and incorporated herein by reference.


