## Executive summary

### Authorizing legislation

The Legislature directed Commerce to prepare a report summarizing progress in issuing grants for community behavioral health facilities in Section 1069(10), Chapter 332, Laws of 2021 (the <u>biennial capital budget</u>):

- (10) The department must provide a progress report by November 1, 2022. The report must include:
- (a) The total number of applications and amount of funding requested;
- (b) A list and description of the projects approved for funding including state funding, total project cost, services anticipated to be provided, bed capacity, and anticipated completion date; and
- (c) A status report of projects that received funding in prior funding rounds, including details about the project completion and the date the facility began providing services.

### Program history

Commerce's Behavioral Health Facilities (BHF) Program funds **community-based behavioral health facilities** in all parts of the state. The number of grants awarded has increased in recent biennia as the state looks to **close the gap between the number of adults and children needing behavioral health treatment, and the limited treatment options available.** Governor Jay Inslee's behavioral health plan calls for more community-based treatment options as the state works to transition individuals civilly committed out of Western and Eastern State Hospitals. This report provides details about the progress of creating new behavioral health facilities, including the number of new projects funded through the BHF Program, their status, cost, location and services provided.

Since the start of the program in the 2013-15 biennium, the BHF Program has **made 189 awards to 174 different projects across a variety of facility types statewide.** Grouping these facility types into five categories, the BHF program has funded **759** crisis behavioral health treatment beds, **763** long-term behavioral health treatment beds, **515** substance use disorder treatment beds, **45** outpatient treatment facilities, and **392** beds in other behavioral health categories.

#### Recommendations

While the BHF Program has significantly increased the number of community-based facilities in our state, Commerce has two recommendations to improve the program:

- Commerce recommends that the Legislature continue making improvements to address the behavioral health workforce shortage, as it did in the 2021-23 biennium when it increased service reimbursement rates, provided grant relief funding to providers, and expanded workforce training programs.
- Commerce also recommends that the Legislature increase the maximum dollar amounts for Behavioral Health Facilities grants.

# Background

More than one in five Washingtonians lives with a behavioral health disorder. However, **approximately half of all adults with a behavioral health disorder do not receive any treatment,** and that number has increased every year since 2011. The suicide rate in Washington has also increased by 36% in the last 10 years. Moreover, a growing percentage of youth live with major depression (currently estimated at 15%), while only about 40% receive any kind of treatment.<sup>8</sup>

In the face of these discouraging trends, Gov. Inslee announced a plan to transform the state's behavioral

health care system. The plan aims to transform Western and Eastern State Hospitals into forensic mental health treatment hospitals, while transitioning civilly committed individuals out of the state hospitals and into community-based treatment settings. The plan also aims to divert individuals from entering the state hospitals by providing community-based care first. Many mental health experts favor community-based treatment because it provides individuals better access to vital supports like family, employment, housing and community resources. It also provides services in a residential setting, rather than an institutional one.

Commerce was key in developing new community-behavioral health facilities. The program's goal is to **fund different types of behavioral health facilities** to meet the varying treatment needs of individuals. Some of these facility types include:

- Children and minor youth facilities: Inpatient or outpatient behavioral health facilities that serve children and minor youth
- Crisis Stabilization: Short-term facilities that assess, diagnose, and treat persons experiencing an acute crisis without the use of hospitalization or jail
- Dementia care: Facilities that provide specialized long-term care services for persons with dementia
- Enhanced Services Facilities: Residential long-term care facilities that provide support and services to persons for whom acute inpatient treatment is not medically necessary
- Evaluation and Treatment: Facilities that provide court-ordered inpatient treatment
- Intensive Behavioral health treatment: Residential facilities that provide 24-hour supervision and specialized treatment for individuals with behavioral health conditions
- Secure Withdrawal Management and Stabilization: Secure facility serving individuals with likelihood of serious harm or who are gravely disabled due to a substance use disorder
- Peer Respites: Peer run facilities for short-term voluntary, non-crisis, services

# Examples of Behavioral Health Facilities projects

#### Pierce County Crisis Recovery Center

The 16-bed Pierce County Crisis Recovery Center (CRC) opened in 2021 in Tacoma. The project received a \$3.15 million grant from Commerce and utilized \$2.95 million in non-state funds. The facility is part of the state's goal to increase crisis stabilization beds, and it has already had successful outcomes:

A guest came to the CRC for stabilization because he was having suicidal ideations. While at the CRC, the guest's family decided they did not want him to return to their home. The guest was having difficulty stabilizing his mental illness, but CRC provided him counseling and restarted his medication, at which point he began to show improvements in his mental acuity. However, since the family did not want him returning home, he was facing homelessness. CRC staff quickly worked on connecting the guest to housing services, and he left the CRC directly into subsidized housing. The guest was also able to continue to manage his mental wellness with outpatient counseling and medication management.

Another guest arrived at the CRC via law enforcement because she was presenting with a behavioral health condition in the community. Before this, the guest had never received crisis services or mental health services. She received assistance with medication management, and the CRC care coordinator set her up with regular outpatient mental health services. CRC also worked with the guest's family to pick up the guest's prescriptions and make sure the guest followed up with her outpatient appointments.

### **Holman Recovery Center**

The Commerce-funded, **36-bed Holman Recovery Center**, in Arlington, opened in 2022. The project received a \$750,000 grant from Commerce, along with \$3.49 million in non-state funds. The facility provides substance use disorder treatment services for people in recovery. The project has already had a host of successful outcomes in its first year of service, including the following:



Holman Recovery Center

One of the first residents at the new facility graduated in March. He remains drug and alcohol free, marking six months clean and sober. He said that, until he came to Holman, he had been doing drugs all his life. He began using drugs at 11 years old and stole automobiles to feed his addition. He tried to get clean all his life. When his daughter was born, he decided he wanted to get clean for her. He came to Holman and immediately said he "could feel how much every single person there actually cared for our

futures. That stuck with me." He credits the people at Holman for his new life, which includes a well-paying job, joint custody of his daughter, and safe housing. "My life is not dark and empty anymore, it is bright and full of hope and opportunity."

- Another guest among Holman's first graduates in March has also remained clean and sober. She said, "I seriously believe this experience has saved my life. I've battled addiction for seven years and after surviving my last attempt to end my life, I wouldn't change anything about my journey leading me to where I am today ... I'll forever be humbled and cherish by my stay at the Holman Recovery Center." She now lives in safe housing and enjoys working with others to help them get to the same stage of recovery that Holman helped her achieve.

# Behavioral Health Facilities Program overview

The Behavioral Health Facilities (BHF) Program provides grants to eligible organizations to **construct, renovate or acquire property to expand behavioral health service capacity.** All projects funded through the BHF Program must commit to provide behavioral health services for at least 15 years (10 years for projects funded before the 2019-21 biennium).

Commerce awards grant funds both through a competitive process and direct appropriations specifically designated for funding by the Legislature. Nonprofits, for-profit businesses, public entities and tribes are all eligible to apply during a competitive funding round. Funding for the program has increased as the state has prioritized community-based treatment, and Commerce strives for geographic diversity when selecting projects.

Commerce **relies heavily on its state and local partners** to administer portions of the BHF Program. Our partners help score applications received during competitive funding rounds and participate in monthly Behavioral Health Facilities Advisory Group meetings. Behavioral health staff from the Department of Social and Health Services (DSHS), Health Care Authority (HCA), and the Department of Health (DOH), along with representatives from the Association of County Human Services, Managed Care Organizations (MCO), Accountable Communities of Health (ACH), and Behavioral Health Administrative Service Organizations (BH-

ASO) all help Commerce craft application questions and score funding proposals. Commerce also coordinates closely with our state agency partners to align the administrative rules and operating funds for the BHF-funded facilities. All facilities are licensed by either DOH or DSHS, depending on the facility type.

#### The BHF-funded projects are grouped into five facility categories:

- Crisis behavioral health treatment (759 beds)
- Long-term behavioral health treatment (763 beds)
- Outpatient treatment (45 facilities)
- Substance use disorder treatment (515 beds)
- Other behavioral health (392 beds)

### Recommendations

Commerce staff hear consistently from providers who want to apply for a facilities grant because they see the need for more services and want to fill that gap. However, many providers say that the **current worker shortages prevents them from applying for a grant** and expanding services. They are concerned about finding enough people to staff new facilities for the full 15-year commitment period.

To address this critical issue, Commerce recommends that the Legislature continue making improvements to address the behavioral health workforce shortage, as it did in the 2021-23 biennium when it increased service reimbursement rates, provided grant relief funding to providers and expanded workforce training programs.

Commerce also recommends that the Legislature increase the maximum dollar amounts for Behavioral Health Facilities grants. Construction costs have increased approximately 20% since 2020,<sup>1,7</sup> and property values in Washington have increased approximately 24%<sup>2</sup> in the same year. **The average cost of a Commerce Behavioral Health Facilities competitively awarded project in the 2019-21 biennium was \$3.2 million.** The **average cost in the 2021-23 biennium was \$4.8 million.** Providing funding allotments that only allow for \$2 million or less in total grant awards reduces the likelihood that providers will apply for a new facilities grant, especially if they are located in an urban area with higher costs.

### New Behavioral Health Model Ordinance

Commerce was charged with **developing a model ordinance** for cities and counties to help site projects awarded Behavioral Health Facilities Program grants in the 2020 supplemental operating budget (Section 127(27), Chapter 357, Laws of 2020). Commerce partnered with BERK Consulting to draft the model ordinance and leverage the firm's knowledge of land use and siting issues.

The Behavioral Health Model Ordinance (PDF), completed in summer 2021, provides example regulatory language to help site community-based behavioral health facilities. Through zoning, jurisdictions can support community providers in expanding capacity and establishing new behavioral health facilities. The ordinance provides options to accommodate new or renovated facilities using existing code and definitions. Local jurisdictions can adopt all or part of the model ordinance or use the Essential

Public Facilities (EPF) process as an alternative.

Adoption of this model ordinance is not required. It was developed as a resource to provide guidance, definitions and code language to expand community-based behavioral health facilities to ensure access to services for people experiencing mental illness or substance use disorders. Absent development regulations that address community-based behavioral health facilities or adoption of this model ordinance, these facilities need to be accommodated under the EPF process.

As a supplement to the model ordinance, Commerce and BERK also developed a <u>Communications Toolkit</u> to help local governments and behavioral health facility developers be **comprehensive and strategic in communications** about community-based behavioral health services and proposed facilities. The toolkit provides strategies and tools that anticipate and address community concerns, and offers examples and lessons learned from previously successful siting efforts.

To ensure both the model ordinance and communications toolkit were comprehensive and collaborative, Commerce convened a broad-based technical advisory committee with planning experts, providers, community partners, tribes, other state agencies and local governments. The committee provided feedback and guidance on the project deliverables. Commerce and BERK, in partnership with the Washington Association of Counties and the Association of Washington Cities, also held four focus group discussions with staff representatives and elected officials to better understand local experiences and perspectives about siting issues, including processes and requirements, challenges, opportunities, and ideas on what should be included in a model ordinance. The final resource documents incorporated many of the recommendations and feedback from committee members, focus group participants, and public comments. BERK has remained an active partner in the project. It provides technical guidance to Commerce, local governments and providers using these resources to build new behavioral health facilities.

# Partnership with Premera

Premera Blue Cross (Premera) approached Commerce to partner in awarding and managing \$6 million in funds from Premera for new crisis stabilization facilities serving rural clients. In 2020, Commerce entered into a memorandum of agreement with Premera to conduct funding rounds and administer the resulting grants for crisis stabilization facilities. This was part of a larger effort by Premera to improve access to behavioral health care in rural areas. Like Commerce's BHF Program, funds are for the construction, acquisition and/or expansion of community-based facilities to increase service capacity.


Commerce assembled a group of behavioral health subject matter experts from different state agencies to develop the competitive funding round. This group included behavioral health experts from the DOH, HCA and DCYF. These representatives, along with staff from Premera and the Commerce BHF team, developed application questions for the competitive funding rounds and evaluated submitted proposals.

Through this partnership, Commerce has conducted two funding rounds and awarded \$4.4 million of the available \$6 million. Five projects received funding for new crisis stabilization facilities. These facilities, with additional funding from other sources, will result in 88 crisis beds and 2 crisis recliners. Four of the five facilities will also provide outpatient crisis stabilization services.

Encouraged by the work so far, Premera recently **pledged an additional \$2 million** for a third funding round, which will launch in fall 2022. This partnership and funding was a result of Premera's awareness of the BHF Program's success across the state.



Crisis Stabilization - A short-term facility designed to assess, diagnose and treat persons experiencing an acute crisis without the use of hospitalization or jail.

Evaluation and Treatment - A facility that provides inpatient treatment to civilly committed individuals. Stays can range from five to 180 days.

90/180 Day Civil Commitment - A specific type of Evaluation and Treatment facility for individuals who are civilly committed to inpatient treatment for longer-term stays of 90 or 180 days.

### Long-term behavioral health treatment




Enhanced Services Facilities – A facility that provides support and services to persons for whom acute inpatient treatment is not medically necessary.

Intensive Behavioral Health – A specialized residential treatment facility for individuals with behavioral health conditions, including individuals discharging or being diverted from state and local hospitals, whose impairment or behaviors do not meet, or no longer meet, criteria for involuntary inpatient commitment, but whose care needs cannot be met in other community placement settings.


Dementia care - A secure facility that provides specialized long-term care services for persons with dementia, including Alzheimer's disease.

# Outpatient treatment



Outpatient treatment – Facilities that provide behavioral health services to patients who live in the community. These facilities do not provide inpatient beds.

### Substance use disorder treatment




### Facility type

- Secure Withdrawal Management and Stabilization / Evaluation and Treatment
- Secure Withdrawal Management and Stabilization
- Substance abuse treatment

Secure Withdrawal Management and Stabilization – A facility that provides care to individuals both voluntarily and involuntarily detained and committed for whom there is a likelihood of serious harm, or who are gravely disabled, due to the presence of a substance use disorder.

Substance abuse treatment – Withdrawal management services provided to an individual to assist in the process of withdrawal from substances in a safe and effective manner.

### Other behavioral health



Peer Respite – A peer-run facility to serve individuals in need of voluntary, short-term, non-crisis services that focus on recovery and wellness.

Psychiatric hospital beds - Inpatient mental health facilities where individuals may go voluntarily or involuntarily.

Residential Treatment - 24-hour on-site care for the evaluation, stabilization, and/or treatment of residents for substance use, mental health, or co-occurring disorders.
