JANUARY 1, 2023 CONTRACT AMENDMENTS

The SCRBH team continues to work with the HCA regarding its 2023 BH-ASO agreement. The current estimated timeline is mid-December. As a result, provider agreements will likely not be ready for review and signature until early February 2023. As always, they will be retroactive to January 1. The HCA has confirmed it will be issuing a new contract. Therefore, to remain in alignment, SCRBH will be issuing new provider agreements as well. CRISIS SYSTEM UPDATES: 988

Who is our Spokane Regional Service Area (RSA) 988 HUB?

Frontier Behavioral Health (FBH) was chosen as the 988 Crisis Lifeline Hub for the Spokane County's RSA. All 988 calls pertaining to Individuals in the Spokane RSA will be routed to FBH. Individuals can call or text 988 or chat 988lifeline.org 24/7 for themselves or a loved one in need of crisis support. For the user, their experience with 988 will appear the same across the state, rollout and implementation will vary from region to region due to available mobile crisis response teams and crisis stabilization services.

Does the Regional Crisis Line (RCL) still exist?

Yes! Although Individuals can call 988 and be routed to FBH Lifeline HUB, the RCL remains active, and Individuals can contact either number in a behavioral health crisis.

Are the services provided different?

Although the numbers may be different, the scope and response of the crisis engagement with Individuals contact the line remains the same for both.

CRISIS SYSTEM UPDATES: 988 (CONT'D)

Washington State is developing the **Native and Strong Lifeline**, the first program of its kind in the nation designed to support American Indian and Alaska Native People. Calls will be answered by Native crisis counselors trained in crisis intervention with an emphasis on cultural and traditional healing practices. If you are a Veteran in crisis or concerned about one, dial 988 and press 1 to be connected to the **Veterans Crisis Line**. The Veterans Crisis Line serves Veterans, service members, National Guard and Reserve members, and those who support them.

SCRBH (ASO) PROGRAM HIGHLIGHTS

Homeless Outreach, Stabilization, and Transition (HOST) Program: In September 2022, the SCRBH (ASO) completed the competitive procurement process for the selection of a provider for the HOST RFP, with Frontier Behavioral Health (FBH) being selected as the recommended provider. The SCRBH (ASO) anticipates the roll-out of this program beginning in December 2022.

Peer Pathfinder - Jail Transitions: Passages Family Support (PFS) Peers assisting Individuals in navigating and obtaining services to address barriers to independence and recovery as they transition back to the community. Services include housing support, resource connection, behavioral health coordination, transportation support, habilitation and rehabilitation services, prevocational, and vocational assistance. Children, Youth, and Family Mobile Crisis (CYMFC) Team Enhancement of Mobile Crisis Services: As of October 2022, the CYFMC Program through Frontier Behavioral Health has been up and running, continuing to build and develop the team while working through workforce challenges. While the CYFMC program enhances and expands existing Mobile Crisis Response (MCR) services, it goes a step further in enabling Children, Youth, Young Adults and families to initiate care based on a self-defined crisis. Interventions are tailored to the Individual and family's unique needs, based on their strengths and considerate of their own culture.
