AGENDA / MINUTES:

1. Welcome and Introductions – Dr. Michael Lemberger

2. Review and Vote on Updated BHAB Bylaws – Dr. Michael Lemberger

- The various updates to the document were reviewed. The change to the membership is due to the reduction of the range of services the ASO provides, as well as to allow for the need for a smaller meeting size. In addition, the proposed change in meeting frequency was discussed and information provided regarding the need to be more adaptive to the reduction of SCRBH (ASO) topics to cover and to ensure productive use of BHAB members time. Justin Johnson and Dr. Lemberger discussed the need to update the Bylaws to be reflective to what is currently being utilized in our community by the SCRBH (ASO), and provided opportunity for the membership to ask questions and respond to proposed changes. No questions arose and no concerns were noted.
- On January 1, 2019, the Spokane Regional Service Area transitioned into Integrated Managed
 Care. The Behavioral Healthcare system was separated from the physical health which was
 combined under Medicaid under Managed Care Organizations (MCOs), for-profit insurance
 companies that oversee both physical and Behavioral Health services for Medicaid, that left twenty
 percent (20%) for the ASO to cover all the Involuntary Treatment Services and the Designated
 Crisis Responders (DCRs).
- Dr. Lemberger asked for motion to approve the updated Bylaws. Ronald Bacon motioned to approve
 the updated Bylaws and Michael Lindsly second the motion. The board unanimously voted to adopt
 the updated Bylaws.

3. Election of 2021 Board Officers – Dr. Michael Lemberger

 Dr. Lemberger asked for motion to approve the new Board Officers; Ronald Bacon motioned to vote in the new officers and Michael Lindsly second the motion. The board unanimously voted in Alexander Knox, Chairperson, and Alicia Paschall, Vice-Chairperson.

DECISIONS:

- The Board unanimously voted to adopt the updated Bylaws to present to the Board of County Commissioners.
- The Board unanimously voted for Alexander Knox, Chairperson, and Alicia Paschall, Vice-Chairperson, as the new 2021 Board Officers.
