**During the summer of 2023, Spokane County had two of the largest and most destructive wildfires in the county's history start on the same day (August 18, 2024). Those fires destroyed the homes, accessory structures, and property of hundreds of Spokane County residents. During the rebuild effort, many Spokane County residents are unable to rebuild quickly and will rely on temporary housing options until their permanent residence is complete. The proposed amendment would allow for a renewal process for temporary uses, when demonstrated need is shown.**

**The intent of the proposal is to provide relief to wildfire victims in Spokane County who had their home or residence destroyed. Temporary housing or other temporary uses could create sewage, use water, create vehicular trips, and potentially create noise.**

- Proposed measures to avoid or reduce such increases are:

**The proposal is intended to affect uses that are temporary in nature. All permitting requirements will remain in place. Sewage disposal requirements, county sound ordinances, etc., shall remain in place and effective. The landowners will be required to demonstrate the need for the temporary use on an annual basis.**

2. How would the proposal be likely to affect plants, animals, fish, or marine life?  
**The burn areas for the Gray and Oregon Road fires were devastating to vegetation and animal habitat. Spokane County anticipates little to no change in post-wildfire conditions in relationship to this proposal.**

- Proposed measures to protect or conserve plants, animals, fish, or marine life are:

**Spokane County Shoreline Ordinance requirements, Critical Areas Ordinance requirements, Floodplain Development Requirements, and Stormwater Requirements all remain in place.**

3. How would the proposal be likely to deplete energy or natural resources?  
**The county anticipates little depletion of natural resources in relation to the adoption of this proposal.**

4. **Spokane County anticipates little affect to environmentally sensitive areas, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands.**

- Proposed measures to protect such resources or to avoid or reduce impacts are:

**Spokane County Shoreline Ordinance requirements, Critical Areas Ordinance requirements, Floodplain Development Requirements, and Stormwater Requirements all remain in place. Areas within the burn areas do contain prime agricultural soils, however the agricultural uses for the prime agricultural soils will still be allowed, and no zoning designation changes are proposed.**

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

**Many of the properties affected by the Gray Fire are located within areas within areas of shoreline environment designations. Properties effected by the fire and within a shoreline environment designation shall be required to obtain building permit approval, meet shoreline, critical areas, and zoning code requirements.**

- Proposed measures to avoid or reduce shoreline and land use impacts are:

**Spokane County shoreline management program requirements are still implemented for structures being re built due to being burned from the wild fire.**
