# **CALL TO ORDER**

The September 25, 2024, public hearing of the Steering Committee of Elected Officials was called to order by Council Member Michael Cathcart, City of Spokane, at 9:04 a.m. A quorum was present.

The meeting was accessible to the public at the City of Spokane Central Library Event Room A, located at 906 West Main Avenue, Spokane, WA, 99201, and via Zoom, with web and telephone links provided in the Spokesman-Review on September 10, 2024.

#### MOTION

Council Member Michael Cathcart entertained a motion to adopt July 17, 2024, and August 21, 2024, minutes. So moved by Rod Higgins; seconded by Commissioner Tim Hattenburg. No discussion. The motion was carried unanimously.

#### MOTION

#### **PUBLIC HEARING**

Tate Andrie presented to the Steering Committee of Elected Officials (SCEO) a recommendation from the Planning Technical Advisory Committee (PTAC) on proposed amendments to the Countywide Planning Policies related to housing and within the context of the very recent legislative acts that have directed changes in GMA.

#### **MOTION**

Council Member Terri Cooper motioned to change the word "should" to the word "may" in the amendment, council member Larry Bowman seconded the motion. Discussion ensued. The motion was carried unanimously.

## **MOTION**

Commissioner Amber Waldref motioned to change the grammatical and minor amendments or typos as necessary to the amendment, council member Rod Higgins seconded the motion. No discussion. The motion was carried unanimously.

## **MOTION**

Council Member Kitty Klitzke moved to amend the Countywide Planning Policies document with the corrections, repost it and continue the hearing discussion in the November Meeting. Council Member Rod Higgins seconded the motion. No discussion. The motion was carried unanimously.

## **WORKSHOP**

#### PTAC recommendation for HAPT "A prime" method

Mr. Thompson presented HPT PTAC recommends that the SCEO adopt HAPT method A prime from the Department of Commerce. This tool can be used to estimate current and future growth and housing needs specifically for Spokane County. This is the commerce update of method A that avoids allocating low income and emergency housing to rural areas. We believe it offers a clear path forward and gives us time to work on the population allocations.

A discussion began. Questions were asked to clarify that the method does not allocate rural housing to the lowest incomes. Transit access was also discussed.

#### **MOTION**

Mayor Terri Cooper motioned to adopt the HAPT method A Prime, council member Rod Higgins seconded the motion. No discussion. The motion was carried unanimously.

# Agreement amendment for Tribal Participation and other issues

Heather Trautman spoke about coordination to communicate growth management requirements for the counties and the cities moving forward, as well as the opportunity for engagement with both the Spokane Tribe of Indians and the Kalispell Tribe of Indians.
